- Codes & Policies applicable to the Directors
- In case the Independent Director is also inducted in the Board Committee(s), he should be provided with the Terms of reference of Committee(s)

The appointment letter issued to Independent Directors inter alia sets out the expectation of the Board from the appointed director, their fiduciary duties and the accompanying liabilities that come with the appointment as director of the Company.

Periodic presentations are being made at the Board and Board Committee Meetings, on business and performance updates of the Company, its subsidiary companies and new launch, business strategy and risks involved. Corporate presentations are regularly circulated to all the Directors including independent Directors. Each director of the Company has complete access to any information relating to the Company. Independent Directors have the freedom to interact with the Company's management as and when required. They are given all the documents sought by them for enabling a good understanding of the Company, its various operations, and the industry segments of which it is a part. Our Familiarisation Programmes also includes visit to company's manufacturing unit, CSR Project and showrooms to enable them to understand the operations of the Company.
